2019 Fall Term

April-July

- Award notifications typically start going out around mid-April
- Schedule an appointment with Debt Management (optional, but recommended)
- M2 Expenses that may need to be purchased in the Fall- Step 1 Exam \$630, Books/ Mandatory Study materials Fee (both of which are included in the COA), Class Dues and Step Prep Materials (not included in the COA)
- **M2- Living Expenses-9 months-August 12th-May 15th (included in the COA)**
- Accept, reduce or decline the financial aid offered
- If this is the first year you accept loans at UAMS, complete Entrance Counseling and the MPN for each loan you accept at <https://studentloans.gov>
